- a. Executive Shapiro turned the attention of the meeting to the reading and adoption of the resolutions.
- b. Resolution 2024-06 authorizing the third renewal of three awarded by the Summit and Medina Workforce Development Board of Workforce Innovation and Opportunity Act funds for a Subrecipient Agreement with Tri-County Jobs for Ohio's Graduates, under the State of Ohio's Comprehensive Case Management Employment Program model, to provide WIOA youth services for the period of 7/1/2024 to 6/30/2025, with no remaining renewal options.
  - Executive Shapiro made a motion to adopt SAMWA COG Resolution 2024-06.
     Commissioner Swedyk seconded the motion. With no objections or abstentions, the motion carried.
- c. Resolution 2024-07 authorizing the third renewal of three awarded by the Summit and Medina Workforce Development Board of Workforce Innovation and Opportunity Act funds for three Subrecipient Agreements with Summit County service providers, under the State of Ohio's Comprehensive Case Management Employment Program model, to provide WIOA youth services for the period of 7/1/2024 to 6/30/2025, with no remaining renewal options.

- Executive Shapiro made a motion to adopt SAMWA COG Resolution 2024-10.
   Commissioner Swedyk seconded the motion. With no objections or abstentions, the motion carried.
- g. Resolution 2024-11 authorizing the Summit and Medina Workforce Area Council of Governments to enter into a Subrecipient Agreement with Project Learn of Summit County to conduct Test of Adult Basic Education assessments for job seekers at the OhioMeansJobs Summit County center for a period beginning 7/1/2024 and ending 6/30/2025 in an amount not to exceed \$70,000.00 of Workforce Innovation and Opportunity Act funds.
  - Executive Shapiro made a motion to adopt SAMWA COG Resolution 2024-11.
     Commissioner Swedyk seconded the motion. With no objections or abstentions, the motion carried.
- h. Resolution 2024-12 to enter into an Intergovernmental Agreement with the County of Summit Department of Job and Family Services for the purpose of reimbursing the Department for costs associated with cost allocation methods, including direct and indirect services, for an initial period beginning 7/1/2024 and ending 6/30/2025 in an amount not to exceed \$225,000.00.
  - Executive Shapiro made a motion to adopt SAMWA COG Resolution 2024-12.
     Commissioner Swedyk seconded the motion. With no objections or abstentions, the motion carried.
- i. Resolution 2024-13 authorizing the Executive Director of the Summit and Medina Workforce Area Council of Governments to execute the first and second renewals on the five-year Lease Agreement with the County of Medina, Ohio, for the lease of approximately 3,175 square feet of office space at 72 Public Square, in the City of Medina, for the period of August 1, 2024 through July 31, 2026, in the amount of \$2,910.41 per month to provide space for the operation of the One-Stop Employment Center in Medina County, known in the State of Ohio as an OhioMeansJobs Center.
  - Executive Shapiro made a motion to adopt SAMWA COG Resolution 2024-13.
     Commissioner Swedyk seconded the motion. With no objections or abstentions, the motion carried.
- j. Resolution 2024-14 adopting Workforce Area 2's Operating and Administrative Budgets for State Fiscal Year 2025 as recommended by the Summit and Medina Workforce Development Board at their meeting held on June 21, 2024.

     Commissioner Swedyk seconded the motion. With no objections or abstentions, the motion carried.
- k. Resolution 2024-15 authorizing the inclusion of Chugach and Equus, and the Summit and Medina Workforce Area Council of Governments as "Additional Partners", defined in The Workforce Innovation and Opportunity Act of 2014 (WIOA), Section 121(b)(2) to the Sate Fiscal Year 2024 and 2025 Local Workforce Area One-Stop Partner Memorandum of Understanding (MOU).
  - Executive Shapiro made a motion to adopt SAMWA COG Resolution 2024-15.
     Commissioner Swedyk seconded the motion. With no objections or abstentions, the motion carried.
- Resolution 2024-16 authorizing the Summit and Medina Workforce Area Council of Governments to extend the Subrecipient Agreement with United Labor Agency to provide Adult

 Commissioner Swedyk seconded the motion. With no objections or abstentions, the motion carried.

- a. Marshall presented "Partnering With Your Local Workforce Area" to the Ohio Child Support Directors Association's County-level attorneys speaking about how the child support system can benefit from having obligors that are not paying their child support.
